Cemetery of the Year Awards 2024

We are delighted to announce that entries are now being welcomed for the Cemetery of the Year Awards 2024!

The competition is open to any Burial Authority within the UK.

The categories are:

- A. Large Burial Grounds above 10,000 graves
- B. Small/Medium Burial Grounds up to 10,000 graves
- C. Parish, Town and Community Councils
- D. The Best First Time CYA Entrant Award, for the highest scoring first entry in CYA.

Please note the closing date for entries is the 30th June 2024.

New for 2024 is that entries need to be accompanied by photos, as extra marks will be awarded at the Judges' discretion during the final adjudication process for maintenance and general appeal of the Cemetery.

The overall winner will receive the prestigious CYA Gold award.

Silver awards will be presented to the runners up in each category and all winners will be featured in the CYA press releases – great for promoting your award-winning cemetery.

Why Register with BRAMM?

BRAMM was founded in 2004 with the aim of establishing a recognised uniform standard of workmanship to meet the requirements of BS 8415 in all burial grounds throughout the UK.

There is no charge to Burial Authorities to join the Register, and the benefits to the Authority are significant in terms of the safety assurance offered by our Registered Memorial Masons. BRAMM simply require Burial Authorities to ensure that:

- · all Memorials are erected to the current British Standard 8415.
- · the Authority recognises the BRAMM Register and allows BRAMM accredited masons to erect **SAFE MEMORIALS** in their cemeteries.

BRAMM (which is significantly the largest Register of Accredited Memorial Masons and Burial Authorities in the UK) will maintain an up-to-date register of Accredited Memorial Masons who have £5m public liability insurance, a health and safety policy and a risk assessment and are required to fix **SAFE MEMORIALS** in compliance with the BS 8415. BRAMM will also provide FREE technical advice. For a Burial Authority to be a BRAMM Burial Authority they simply have to ask that new SAFE MEMORIALS are erected (in compliance with the current BS 8415) and that the mason/fixers are registered with BRAMM.

BRAMM is fully supported and endorsed by the leading industry organisations:

- · ICCM—Institute of Cemetery and Crematorium Management,
- · FBCA—Federation of Burial and Cremation Authorities,
- · SLCC—Society of Local Council Clerks.
- · CWGC—Commonwealth War Graves Commission
- · EJA—Ecclesiastical Judges Association

The above organisations have equal representation and sit alongside independent Memorial Masons on the BRAMM Board to ensure fair, transparent and non-biased discussion and decision making.
